## Mount Sunapee, Okemo and Stowe to open with First Chair celebrations

**(STOWE/LUDLOW), Vt. - Nov. 20, 2019 -** Stowe and Okemo, in Vermont, and Mount Sunapee, in New Hampshire, will each celebrate their opening day of the 2019/2020 ski and snowboard season with First Chair festivities.
