## Katz Amsterdam Charitable Trust Donates \$150,000 to Launch EforAll's EparaTodos Accelerator in Longmont, Colo.

The new EparaTodos Accelerator will share the same structure as the English accelerator currently offered in Longmont. The free one-year program, offered twice a year, provides a unique combination of immersive business training and access to an extended professional network for those wishing to start or grow a business or nonprofit. It also includes opportunity for mentorship. Entrepreneurs meet with a dedicated team of mentors, which will include Vail Resorts business leaders, to guide them in taking their idea to the next level.

Grant funds from the Katz Amsterdam Charitable Trust will support the hiring of a bilingual program manager for the EparaTodos Accelerator, help fund the day-to-day operations of the program, and contribute to cash awards given to Accelerator graduates.

"We couldn't be more excited to be partnering with the Katz Amsterdam Charitable Trust as well as Vail Resorts," said Harris Rollinger, EforAll Longmont's executive director. "This gift will accelerate the launch of EparaTodos in Longmont and ensure that we are well positioned to execute our outreach efforts across Boulder County. Rob and Elana are clearly so passionate about supporting small businesses and with their support, EforAll Longmont will reach countless aspiring entrepreneurs and help them launch businesses that transform communities."
